WHAT: “Lift the Welcome Torch” - a recorded program featuring community and faith partners demonstrating support for welcoming refugees, sponsored by the Interfaith Immigration Coalition, We Are All America, Disciples Refugee & Immigration Ministries, and Refugee Council USA.

The program will feature short testimonies from former refugees who have made the U.S. their home, as well as faith and community leaders, calling for Congress and the Administration to recognize refugees’ contributions and recommit our country to being a beacon of hope and a lifeline for people in search of safety.

WHY: Learn how to take action to support a more robust commitment to refugees in U.S. policy! On 10/27, a federal appeals court will hold oral arguments in a lawsuit against the Trump administration’s attempt to restrict refugee resettlements in the United States, by requiring states to affirmatively agree to accepting refugee residents (Executive Order 13888).

The lawsuit was brought by the International Refugee Assistance Project on behalf of HIAS, Church World Service, and Lutheran Immigration and Refugee Services. This hearing before the U.S. Circuit Court of Appeals for the Fourth District takes place the same week that the administration and Congress are poised to finalize refugee resettlement numbers for FY 2021. This is expected to be the lowest resettlement number in the program’s history.

Call Your US Senators & Representative to Ask They Urge the Administration to Restore the Refugee Resettlement Program and Welcome Refugees

Sample Email/Script: "I'm a faith/community leader/refugee constituent from [CITY/TOWN], and I urge you to protect the refugee resettlement program. My values of welcome and hospitality are deeply at odds with the consistently lower refugee numbers approved over recent years, down from an average of 95,000 to this year's request for a cap of only 15,000. Refugees bring much value to our communities and churches, businesses, etc. [share how refugees support YOUR area!]-including the 176,000 serving as healthcare workers and 175,000 working in the food supply chain during COVID! *Therefore, please:*

- 1) *Ensure the President will quickly sign a refugee admissions goal for FY2021, as resettlement is currently halted until then Also,*

- 2) *Oppose the 15,000 proposed refugee cap, and instead restore our US resettlement to 95,000 per year, &*
- 3) *Establish an “other” category in this year’s admissions guidelines to allow for the most needy refugees--and the full admissions goal number--to be admitted.*

My community welcomes refugees, and I urge you to reflect the best of our nation by supporting refugee resettlement.”
